### **Course Description:**

This 1-credit seminar will provide an opportunity for members of the 2019 cohort to engage with issues and people in the field of human rights. In our first semester, we met with a cross-section of human rights professionals who shared their experience in areas such as diplomacy, domestic human rights commissions, leadership styles, press conferences, presentation skills and quantitative research. Our goal this semester is to continue to build the strengths of each student, so that he/she feels confident and prepared to pursue human rights work outside the classroom. We will work on interview skills and resume construction. We will discuss fact-finding, negotiations, United Nations work, and revisit self-care. We will continue to feature guest experts from the community of practice to share their expertise on these particular skill sets.

### **January 30, 2018**

**Guest: Professor Fionnuala Ní Aoláin**, *United Nations Special Rapporteur for the Protection and Promotion of Human Rights while Countering Terrorism*

Professor Fionnuala Ní Aoláin is a University Regents Professor; holder of the Robina Chair in Law, Public Policy, and Society; and faculty director of the Human Rights Center at the Law School. She is concurrently a professor of law at the University of Ulster's Transitional Justice Institute in Belfast, Northern Ireland, and is co-founder and associate director of the Institute.

Her teaching and research interests are in the fields of international law, human rights law, national security law, transitional justice, and feminist legal theory. She has published widely in the fields of emergency powers, conflict regulation, transitional justice, and sex-based violence in times of war and continues to write extensively on theoretical aspects of transition.

### **February 13, 2018**

*Advocacy: Social Justice, Racial Equality*

**Guest: Nekima Levy Pounds**

Nekima Levy-Pounds is a civil rights attorney, former law professor, political activist, legal scholar, and national expert on issues at the intersections of race, public policy, economic justice, public education, juvenile justice, and the criminal justice system. She previously served as a Professor of Law at the University of St. Thomas Law School for thirteen years, where she founded and directed the Community Justice Project, an award-winning civil rights legal clinic.

Currently, Nekima is owner and principal consultant of Black Pearl, LLC, a multi-faceted company that provides business consulting, talent management, and media management services. In 2017, she was named 100 People to Know by TwIn Cities Business. In 2016, she received the Distinguished Service Award from the Governor's Commission on Martin Luther King Day. In 2015, she was named one of "40 Under 40" by Minneapolis/St. Paul Business Journal. In 2014, she was named a "Minnesota Attorney of the Year" by Minnesota Lawyer and recognized as one of "50 Under 50 Most Influential Law Professors of Color in the Country" by Lawyers of Color Magazine. She previously served as president of the Minneapolis NAACP and as an advisor to Black Lives Matter Minneapolis. She ran for Mayor of Minneapolis in 2017.

### **February 27, 2018**

*Negotiations*

**Guest: Margaret Anderson Kelliher**

Margaret Anderson Kelliher is the president and CEO of the Minnesota High Tech Association (MHTA). Prior to MHTA, Anderson Kelliher served in the Minnesota legislature, including two terms as Speaker of the Minnesota House of Representatives. Characterized as the "calm inside the storm" by the Star Tribune, Anderson Kelliher is recognized as a strong, pragmatic leader. As House Speaker, she guided passage of a nation-leading renewable energy standard, built a broad coalition to enact Minnesota's first comprehensive transportation funding bill in 20 years, and was a champion of Minnesota's Angel Investment Tax Credit. Anderson Kelliher chairs Governor Dayton's Broadband Task Force, as well as the Minnesota Ballpark Authority Board of Commissioners. She has a BA in political science from Gustavus Adolphus College and a Master's in Public Administration from the Kennedy School of Government at Harvard University.

## **March 20, 2018**

*Social Media as an Advocacy Tool*

**Guest: Sarah Super, Founder of Break the Silence**

Sarah Super founded a movement for sexual assault survivors to publicly say their names and share their stories. Ms. Super developed a protocol for community truth-tellings and a faces-of-survivors photography project, organizes rallies and protests to stand with survivors and hold perpetrators accountable. In 2016, she successfully lobbied the City of Minneapolis to declare "Break the Silence Day" in August 2016. She is currently working with the Minneapolis Parks & Recreation Board to build the nation's first memorial to honor survivors.
